RESERVATIONS/PAYMENT BREAKDOWN: A deposit is required at the time of booking and NO request will be acted upon until a deposit is received. Deposits can be conveniently made by phone. Final payment with credit cards require our signed Credit Card authorization form, validated by the credit card holder. Other restrictions may apply. Deposit Requirements: A \$300 per person deposit is due at time of booking. Final payment is due 60 days prior to departure. All requests received within 60 days must be paid in full. Tour documents will be delivered electronically approximately 2 to 3 weeks prior to your departure.

CANCELLATION AND REFUND

Deposits, Airfares and Travel Insurance (Travel Protection Plan) are 100% non-refundable and non-transferrable

In the event of cancellations, the following charges will apply:

- More than 60 days prior to tour start date: **Non refundable deposits** in addition to any and all additional expenses already incurred on behalf of the travelers. Such expenses include, but are not necessarily limited to, airline tickets, full payments tendered for hotel accommodations, transportation services or other.
- From 59 to 46 days prior to tour start date: **25%** of the cost of the land package
- From 45 - 31 days of tour start date: **50%** of the cost of the land package
- From 30 - 15 days of tour start date: **75%** of the cost of the land package
- From 14 days to the day of the tour start date: **100%** of the cost of the land package – **NO REFUND**
- No refund will be made for unused portion/services of any tour package.

LATE BOOKINGS (Reservations made within 35 days of departure date): Payments must be made within 24 hours of booking by certified check, wire transfer or credit card, and are subject to a \$35 late-booking fee, plus any costs incurred to ensure timely document delivery. Late bookings will incur a 100% cancellation penalty.
